2023 CANOE RESERVATION CONTRACT

BY SUBMITTING YOUR DEPOSIT, YOU ARE ACKNOWLEDGING THAT YOU HAVE READ AND UNDERSTOOD THIS CONTRACT, AND YOU AGREE TO ITS TERMS AND CONDITIONS.

**Please read carefully before submitting your deposit. PRINT, SIGN and RETURN A COPY TO NOAH'S ARK.
KEEP A COPY FOR YOUR REFERENCE.**

RESERVATION AND PRICE POLICIES

1. Noah's Ark Adventure Company, LLC (herein referred to as NA) will hold your trip date for two weeks from the day we receive your reservation request.
2. If NA does not receive your deposit by the due date, your trip will be cancelled.
3. This is a group reservation. Each member of your group will be charged for each activity on the reservation regardless of participation.
4. All deposits and payments due before May 1 must be paid with *check or money order*. Visa/Mastercard deposits and payments under \$1000 will be accepted after May 1 of each reservation year, but checks are preferred. Payments over \$1000 must be made by check.
5. **Final payment in full is due two weeks prior to your trip start date.** No billing is accepted. A \$100.00 charge will be added to your total trip cost if payment in full is not made by this date. Individual payments will not be accepted. **YOU WILL BE RESPONSIBLE FOR FULL PAYMENT FOR ANY REDUCTIONS IN YOUR NUMBER OF PARTICIPANTS WITHIN TWO WEEKS OF YOUR ARRIVAL DATE.**
6. The price quoted for your trip is valid based upon current trip itinerary and numbers. Any change in your trip itinerary or numbers will affect your trip price, and an updated statement will be issued to you.
7. All agreements must be in writing.
8. By paying any deposit money you agree to all terms, conditions, and policies of this agreement.

GENERAL POLICIES

- Number changes.....NA cannot guarantee that we will be able to accommodate increases in numbers over the reserved numbers listed on the reservation statement. Please call in advance to check on availability for increases in numbers.
- InsuranceParticipants may be covered under their own personal insurance. NA is not responsible for costs associated with any physical injuries that occur while participating in NA activities or on the Noah's Ark Campground. In the case of an evacuation, NA will not be responsible for providing lodging for evacuees while the rest of the group completes the trip.
- Alcohol and DrugsNo alcohol, marijuana or illegal drugs are allowed on any trips taken with NA or on the Noah's Ark campground.
- Minor Participants.....All canoe trips with minor participants (under 18) must be accompanied by at least **TWO** adult sponsors.
- Release FormsAll participants will be required to sign a release of liability form before they will be allowed to participate in any NA activities. If you would like further information regarding the form, please contact our office.
*Photocopies will be accepted only if legible and complete. **Participants under 18 must have a parent's or guardian's signature.***
- Inclement WeatherNA reserves the right to cancel any activity in the unlikely event of inclement weather. If ANY activity is cancelled due to weather, we may try to reschedule to another time or replace the activity with another activity based on availability. There is no guarantee that a weather-related cancellation will be rescheduled or replaced. There is no refund for activities that are cancelled due to inclement weather.
- Gratuity.....Gratuity is not included in the trip price. Tipping is considered common practice in the rafting and adventure industry. 10-20% is recommended for multi-day trips. Tips are always greatly appreciated, but never expected. We encourage tipping as an expression of your appreciation for excellent service from the guide staff.

REFUND POLICY

There will be no full or partial refunds for any reason, including:

1. Missing scheduled meals and weather-related cancellations.
2. Missing a scheduled trip departure time. If you miss a departure time you will be required to make full payment for the trip.
3. Non-participation. Each member of your group will be charged for each activity regardless of participation.

DEPOSIT / PAYMENT POLICIES

FULL PAYMENT IS DUE TWO WEEKS PRIOR TO THE TRIP START DATE.

IF PAYMENTS ARE NOT RECEIVED ON TIME, YOUR TRIP WILL BE CANCELLED.

Payment Schedule:

1. \$200.00 per person deposit due within two weeks after time of reservation
2. **FULL PAYMENT** of the remaining balance is due two weeks before trip start date
3. If reservation is made within 2 weeks of trip, full payment is due at time of reservation.

*NA reserves the right to cancel a trip if the deposit is not received by the appropriate due date. All deposit money paid is non-refundable.

TRIP CANCELLATION POLICY

If you cancel your canoe trip, you will incur a cancellation penalty based on the following schedule:

| 3. Cancellation of trip less than 2 weeks before trip..... | FULL TRIP PAYMENT AND DEPOSIT held |

DECREASES IN TRIP NUMBER POLICIES

If your trip numbers decrease from your original reservation, you will incur a penalty based on the following schedule:

1. Prior to February 1 – 50% of your deposit per person is held for any drops (reductions in number of participants) beyond the allowed number according to the chart below, and you will be charged FULL PER PERSON COST for any remaining spots.
2. After February 1—Fee equivalent to FULL PER PERSON COST charged per drop beyond allowed number of drops
3. ANY drops in number less than 2 weeks before your start date—FULL PER PERSON COST charged per drop.

You may not use “Free Drops” less than 2 weeks before your trip.

- o NA reserves the right to cancel a trip that falls below the minimum number of participants (minimum 8)
- o The Free Drop Policy is based on initial booking number, or highest number if you increase your group size.
- o You may not use “Free Drops” less than 2 weeks before your trip.

RIVER TRIP POLICIES

1. NA will divide your group into the appropriate number of canoes. Weight, age, ability, water flows and conditions determine the number of people per canoe. There is a possibility your group will be in canoes with people from other groups. NA reserves the right to refuse service to anyone for any reason, including, but not limited to physical fitness, age, and perceived use of alcohol or drugs.
2. NA reserves the right to substitute alternate river sections for a more appropriate trip for your group, based on high or low water conditions.

We reserve the right to substitute or cancel for any reason, based solely on our discretion. These reasons may include, but are not limited to insufficient physical ability, experience level, age, number in group, water conditions or inappropriate water levels.
